# **Consent Agenda**

Wayne McClain called meeting to order and confirmed there was a quorum present.

Consent Agenda includes approval of the following:

Wayne McClain made motion to approve minutes. First – Jake Schickel. Second – Elaine Johnson.

Motion unanimously accepted consent agenda and approved the three items.

# **Operations Update, Rebecca Livingston**

Reviewed employment figures for the Northeast Florida (NEFL) region. Reviewed the December unemployment statistics of 3.2% across the region which is the same percentage as the state of Florida.

Center visits peeked in September 2021 with a decrease during the holiday months. CSNEFL anticipates an increase of 10% to 15% in center visits in February from January. More individuals are coming to centers looking for jobs and less are asking for assistance with reemployment assistance (RA).

Job order trends – in January 2022 there were over 3300 job orders compared to 2800 job orders in January 2020 (before pandemic). In October 2021 we had the largest spike of job orders in the last several years.

By industry, the finance and insurance industry had the highest amount of job growth in our region. The healthcare industry had the second highest.

Jobs most impacted by COVID- 19 include administrative support which spiked in job growth when others did not. Accommodation/food service decreased at the end of the year but anticipate job growth to increase again in 2022.

Question: Elaine Johnson asked if we have seen an increase in job seekers attending job fairs?

There has been an increase in job seekers at events. CSNEFL has several events scheduled:

- 1) Spring Job Fair with FSCJ in March
- 2) Virtual Job Fair in April
- 3) Partnering with High schools (Duval, Clay, and Baker) with their senior recruitment nights

Question: Jake Schickel – has there been much reaction to the Entrepreneurship article? Suggested to make sure we include more information regarding the steps to connect with CareerSource NEFL.

Comment: Clay Lyons stated how helpful the CareerSource staff is in helping job seekers.

#### SNAP Funding Update, Rebecca Livingston

CSNEFL received about have of our funding for SNAP E&T. This lack of funding is happening across all regions in the state. The limit is due to DCF working with the Federal government to approve the state plan. Beginning of this month, CSNEFL ran out of SNAP funding and, as a result, CSNEFL came close to discontinuing services for SNAP customers. However, we received additional funding to provide services through April. Clarified that CSNEFL does not provide the food stamp benefits, rather CSNEFL provides the support to ensure SNAP customers are looking for jobs and related supports for employment. Therefore, if we are forced to discontinue benefits due to lack of funding, this should not directly impact SNAP customers getting their benefits. We continue to watch this closely.

## **Regional Workforce Forum**

Planning the Forum which will be held at UNF on April 28<sup>th</sup> and is titled "Recruiting, Retaining, and Reskilling in the Changing Economy." Target is businesses

Board meeting will be in the morning and forum in the afternoon.

Speakers – Ron Hetrick, EMSI/Burning Glass to talk about demographic draught and key learnings. Sonia Malik, Learning Alliance Manager for IBM Training and Skills – talk about some of the innovative things

IMB is doing to ensure it has the talent now and in the future. Followed by local panelists to talk about the topic.

- CSNEFL will host a summer internship program called CHOICES.

- Cost to businesses is only employee time and equipment to complete tasks.
- Coordinating point is Youth Services.
